**A RESOLUTION OF THE TOWNSHIP OF TINICUM, DELAWARE COUNTY,
PENNSYLVANIA; AMENDING THE TAPPING FEES**

BE IT ENACTED AND ORDAINED by the Board of Commissioners of the Township of Tinicum, County of Delaware, Commonwealth of Pennsylvania, as follows:

COMPUTATION OF CHARGES

A tapping fee in the amount of Eight Hundred Three Dollars and Forty Four Cents (\$803.44) shall be required for each residential dwelling unit or part thereof.

Non-residential units shall be charged \$3.59 per gallon of usage.

The tapping fee shall be due the Township upon application for a Building Permit or Use and Occupancy Application, whatever Application or event occurs first in time.

BE IT RESOLVED, this 20th day of June, 2005.

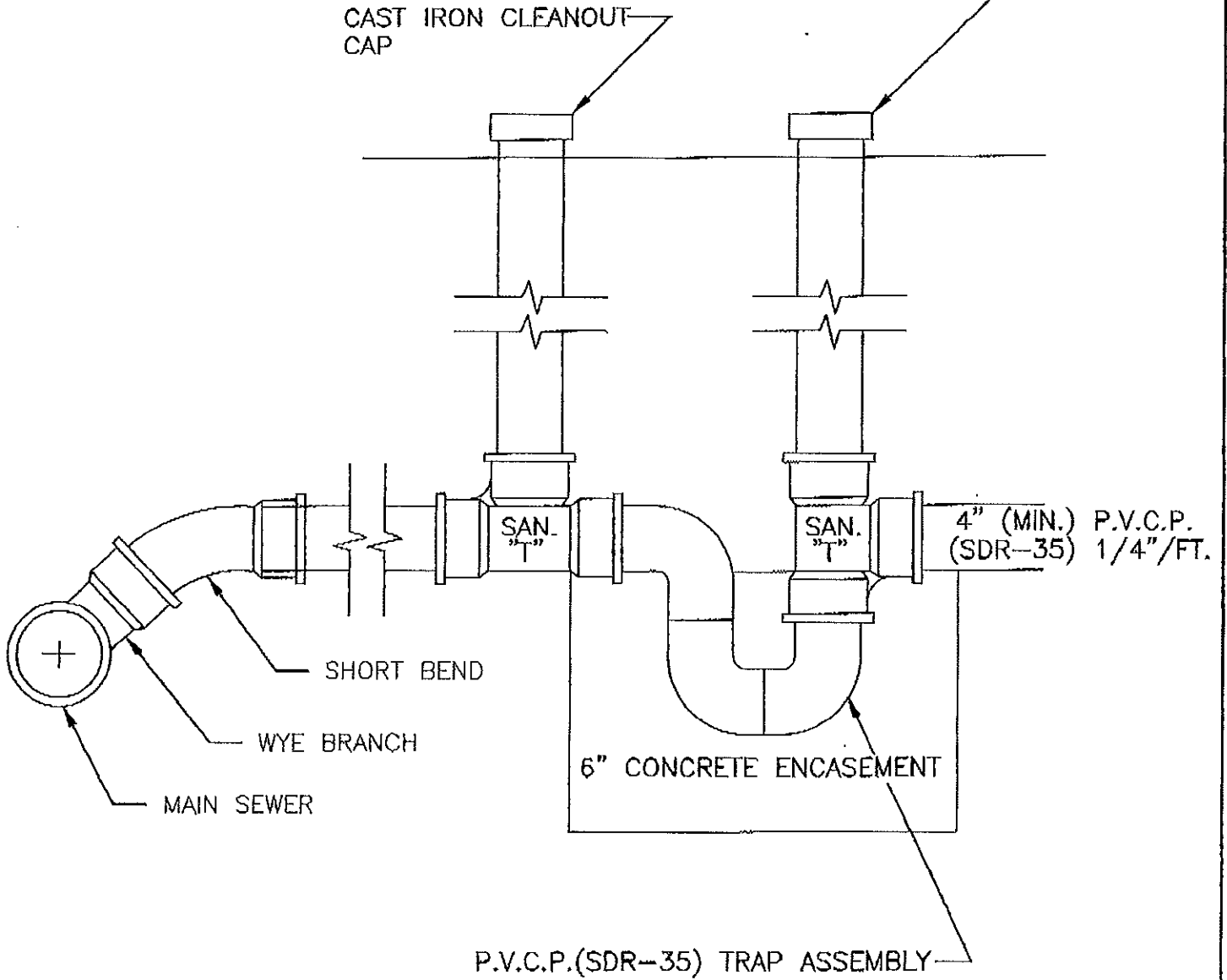

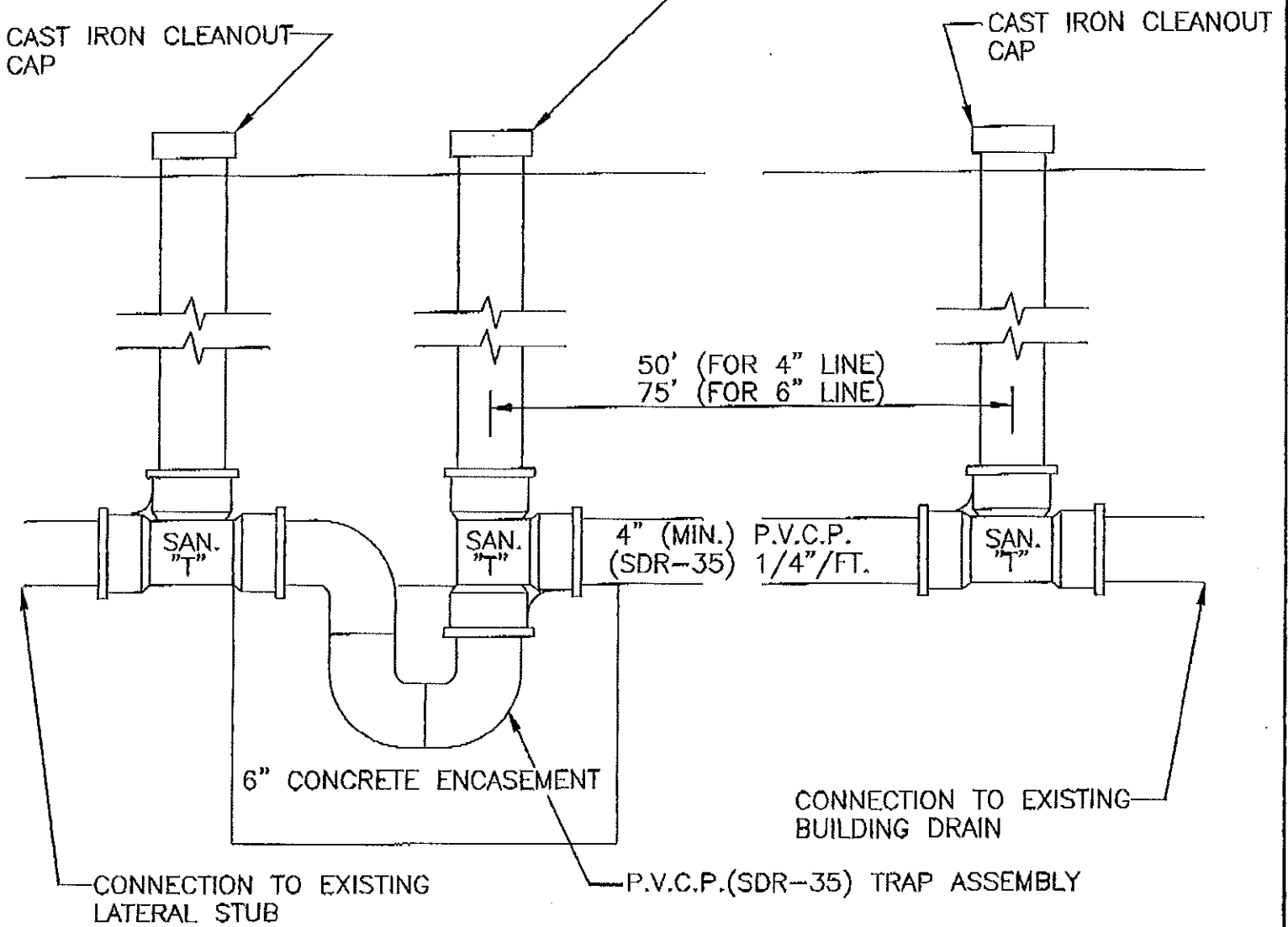
